- <u>SB24-214</u>: Implement State Climate Goals Concerning the implementation of state climate goals, and, in connection therewith, making and reducing an appropriation.
- <u>SB24-229</u>: Ozone Mitigation Measures Concerning measures to mitigate ozone pollution in the state, and, in connection therewith, making an appropriation.
- <u>SB24-230</u>: Oil & Gas Production Fees -Concerning support for statewide remediation services that positively impact the environment.
- <u>HB24-1338</u>: Cumulative Impacts & Environmental Justice Concerning measures to advance environmental justice by reducing cumulative impacts of air pollution, and, in connection therewith, making an appropriation.

Taxation

• Moni Grushkin (U) is unchallenged to retain her seat as Treasurer.

Unemployment Rates

- Statewide unemployment rate was 3.5% in February and 3.7% in March.
- La Plata County was 4.2% in February and 3.7% in March..
- San Juan County was 3.2% in February and 3.3% in March.
- Archuleta County was 4.5% in February and 4/0% in March.
- Montezuma County was 6% in February and 5/3% in March.

Durango City Council Updates

- May 7th was the first reading of an ordinance to update the Land Use and Development Code regarding the Fair Share (Inclusionary Zoning) Program. Key objectives include:
 - Extending the program to include rental developments
 - o Incentivizing developers to construct units rather than paying the fee in lieu
 - Simplifying the program
- Durango City Council approved a resolution adopting a new schedule for Building Permit Fees. Under the 2023 Valuation approved, the fees collected are projected to increase 40%.
- City Council adopted an Economic Development Incentive policy for Durango that would be used to strategically drive
 sustainable growth, bridge market gaps, bolster local enterprises, retain growing businesses, create jobs, and establish a
 resilient economic foundation capable of withstanding challenges. City staff said the economic incentives will be used
 judiciously, selectively, and by exception as supplementary measures.
- City Council also approved Durango's participation in the state of Colorado's Rural Jump-Start Zone program. The program was passed in 2015 as a tax relief program for out-of-state relocating businesses and new hires who locate into rural areas. If a business is approved, the program offers benefits for companies starting up or relocating into Colorado that include help with start-up costs and tax reliefs.

Housing Update

• Durango Community Development Director Scott Shine said the Residences at Durango hotel conversion project is ahead of schedule and will be offering affordable housing opportunities by the end of this year. Renovation and remodeling of the former hotel will bring a mix of studios, 1 and 2 bedroom apartments by the fourth quarter of this year, while additional new construction will be completed likely in the first quarter of 2025.

La Plata County Road Impact Fee

• La Plata County is collecting input on a proposed road impact fee on new development in the unincorporated county. Under the proposal, a 901 to 1500 square feet dwelling unit would have a fee of \$2,000. 1000 square feet of commercial development would have a fee of \$8,000. It's estimated the fees will raise about a half a million dollars per year towards the county's nearly \$203 million estimated needs through 2045.

Economic Development Alliance Update

• La Plata Economic Development Alliance Executive Director Mike French will be transitioning out of his position over the next couple of months, while Deputy Director Sarah Tober will begin taking over. Tober will become the Executive Director officially as of July 1, 2024.

Durango Chamber of Commerce Update

• Chamber of Commerce CEO Jack Llewelyn has stepped down after 17 years of service. COO Kim Oyler will act as Interim CEO as a national search is underway.
