Preventive Measures

- Take all common-sense precautions against contracting and spreading COVID-19, we suggest:
 - Wash and sanitize hands frequently.
 - Maintain 6 feet of social distance (other than with immediate family/roommates in your home).
 - Wear a mask in indoor public settings and outdoor public settings where social distancing cannot be followed.
 - Handkerchiefs and buffs should not be worn. Double-ply masks that hook around the ears or around the head are best.
 - Wear a mask in private settings when social distancing cannot be followed (e.g, driving).

Mindful Socializing

- In addition to the preventative practices above:
 - Prioritize socializing outdoors.
 - o Avoid groups of 10 or more.
 - Avoid going out of your "bubble" or household when possible.
 - o If you chose to engage in a public setting (e.g., restaurant, salon) avoid the "3 C's":
 - closed spaces, crowded places, and close contact settings.

- Limit personal travel, prioritizing essential activities and travel.
- In advance of extended travel/time off requests, please communicate your plans to your manager.
- Be mindful of going outside of your "pod" when traveling.

Communal Work Spaces

- Wear a mask when entering the building, in all communal workspaces, and in all other designated areas.
- Hold all meetings via Zoom when possible.
- In-person meetings, when required, will take place with 6 feet of social distance and with all participants wearing a mask.
- When weather permits, hold in-person meetings outdoors.

Screening, Reporting & Testing

- When reporting for work, complete COVID Screening Log (Insert location here).
- Monitor your symptoms daily. If you have concerns in between reporting times, please contact your manager.
 - You must be symptom-free for 72 hours before you are allowed to return to work.
- We suggest that you register your phone with CO Exposure Notifications (free app)
 - iPhone users can enable CO Exposure Notifications in their phone settings by finding Settings > Exposure Notifications > United States > Colorado.
 - o Android users can download CO Exposure Notifications on the Google Play store.
- Utilize the free local testing program if you have concerns about symptoms or exposure, and communicate the testing plan with your manager.

- Refer to and follow Colorado Executive Order guidelines if you qualify as a "Vulnerable Individual" (e.g., immunocompromised, pregnant, or as determined by a licensed healthcare provider).
- Refer to and follow all other guidelines as applicable in the Colorado Executive Order.
